The City Council of the City of Gainesville, Texas met in regular session November 16, 2021 at 6:30 p.m. with the following persons in attendance.

Mayor Pro Tem Ken Keeler called the meeting to order at 6:30 p.m.

**CONSENT AGENDA**

Council reviewed the Minutes of the City Council Meeting on November 2, 2021 and approved them as written.

Councilmember Hendricks **moved to approve the Consent Agenda.** The motion was seconded by Councilmember Eberhart and carried by vote of 6 Ayes, 0 Nays, 0 Abstentions, 1 Absent (Moore).

**RESOLUTION 11-16-2021 - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GAINESVILLE, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE RELEASE OF LIENS AGAINST A PROPERTY AT 503 NORTH MORRIS STREET, GAINESVILLE, TEXAS TO BE SOLD AT SHERIFF'S SALE.**

Approved a Resolution to release liens in the amount of \$16,659.59 for the property located at 503 North Morris Street to be sold at the next scheduled Sheriff's Sale.

Councilmember Dollar **moved to approve the Resolution.** The motion was seconded by Councilmember Hill and carried by vote of 6 Ayes, 0 Nays, 0 Abstentions, 1 Absent (Moore).

**RESOLUTION 11-16-2021A - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GAINESVILLE, TEXAS, AUTHORIZING THE CITY MANAGER TO EXECUTE RELEASE OF LIENS AGAINST A PROPERTY AT 429 SCHOPMEYER STREET, GAINESVILLE, TEXAS TO BE SOLD AT SHERIFF'S SALE.**

Approved a Resolution to release liens in the amount of \$2,209.55 for the property located at 429 Schopmeyer Street to be sold at the next scheduled Sheriff's Sale.

Councilmember Dollar **moved to approve the Resolution.** The motion was seconded by Councilmember Eberhart and carried by vote of 6 Ayes, 0 Nays, 0 Abstentions, 1 Absent (Moore).

**RESOLUTION 11-16-2021B - A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GAINESVILLE, TEXAS, AUTHORIZING EXPENDITURES FOR PURCHASE OF ONE (1) 2023 AUTOCAR CHASSIS FROM CHASTANG'S BAYOU CITY WITH GALFAB OR60-174 ROLL-OFF HOIST FOR THE SOLID WASTE DIVISION.**

Approved a Resolution to authorize the purchase of an AutoCar Chassis from Chastang's Bayou City with Galfab OR60-174 Roll-Off Hoist Truck in the amount of two hundred eleven thousand, seven hundred forty-nine dollars (\$211,749.00).

Councilmember Eberhart **moved to approve the Resolution.** The motion was seconded by Councilmember Hill and carried by vote of 6 Ayes, 0 Nays, 0 Abstentions, 1 Absent (Moore).

**RESOLUTION 11-16-2021C- A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GAINESVILLE, TEXAS, AUTHORIZING EXPENDITURES FOR PURCHASE OF ONE (1) 2022 TRAVIS LIVE FLOOR TRANSFER TRAILER FOR THE SOLID WASTE DIVISION.**


Approved a Resolution to authorize the purchase for one (1) 2022 Travis Live Floor Transfer Trailer in the amount of ninety-one thousand, seventy-two dollars and seventy cents (\$91,072.70).
