The **second item of business** was Discussion and Action on minutes from January 14, 2019. A motion to approve the minutes was made by Mr. Ayers with a second from Ms. Brannon. Ayes: Ayers, Brannon, Fogle, and Johnson. Nays: None. Absent: Green and Russell.

The **third item of business** was Citizen/Tenant comments. None

The **fourth item of business** was Discussion on Hangar Development. Director Vinton advised the board that Mr. Burris was interested in building a hangar complex at the airport. Discussion on where, past experience, and fire sprinkler requirements ensued. The Board thanked Mr. Burris for his input and interest in the airport

The **fifth item of business** was Discussion and Action on Gainesville Flyers Request for Consumption of Alcohol on Airport Property. Mr. Ayers advised the Board that the Local Chapter of the EAA will be hosting their 6th annual Crawfish Boil fundraiser on May 4, 2019. He stated that the chapter is requesting that the consumption of alcohol be permitted in and about the chapter's hangar located at 2350 Airport Dr. from the hours of 3:00pm till 11:59pm. Mr. Ayers advised the Board that this is a Non-Profit organization and no sales of alcohol will be permitted. Mr. Ayers then stated that the chapter will provide the City with an insurance coverage policy and that chapter officers will self-police the event.

Mr. Snuggs made a motion to grant the request with a second by Mr. Fogle. Ayes: Brannon, Fogle, and Johnson. Nays: None. Absent: Green and Russell. Recuse: Ayers

The **sixth item of business** was Discussion and Action on Land Lease to Jim Street. Director Vinton advised the board that Mr. Street is requesting an 80' X 108' land lease for construction of a hangar directly west of the South airport entrance. A motion to approve was made by Mr. Ayers with a second from Mr. Snuggs. Ayes: Ayers, Brannon, Fogle, and Johnson. Nays: None. Absent: Green and Russell.



The **seventh item of business** was Airport Director reports. The Director discussed the fuel reports with the Board. Mr. Vinton advised the board that a construction firm has been selected and that the final plans are being drawn up as we meet. Mr. Snuggs stated that he would like to see some drainage work on the North side of the 200 series hangars in next year's budget.
