
The **third item of business** was Citizen/Tenant comments. Mr. Ayers recommended that the airport begin spending monies on a new fuel pump and nozzle. He further advised that the North gate needs a "tune-up" as it has failed to operate several times over the past few weeks. Mr. Fogle inquired about the hangar waiting list and if the airport needed to increase the rent structure to meet the demand.

The **fourth item of business** was Election of Board Chairperson and Vice-Chairperson. Mr. Johnson Made a motion to have Mr. Ayers as the Board Chairperson with a second from Mr. Fogle. Ayes: Johnson. Nays: Fogle, Green. Recuse: Ayers. Absent: Brannon, Russell. Motion Failed. Mr. Green made a motion to have Mr. Snuggs as Chairperson and Mr. Ayers as Vice-Chairperson with a second by Mr. Fogle. Ayes: Fogle, Green, and Johnson. Nays: None. Recuse: Ayers, Snuggs. Absent: Brannon, Russell.

The **fifth item of business** was Discussion on the Airport Improvements. Director Vinton advised the Board of the various parties that is interested in leasing parcels for new hangar construction. Mr. Vinton stated that he will be requesting quotes for ground radar services so we can have a grasp on underground obstacles prior to leasing a plot of land for development.

The **sixth item of business** was Airport Director reports. The Director reviewed the fuel reports with the Board. Mr. Vinton advised the Board that the access road is about to open and that it drives real smooth. He also stated that it will be a huge asset to the airport and our clientele compared to the previous road. Director Vinton advised the board that the Avgas fuel pump has been down more than it has been working the last 2 weeks. He stated that he hopes to be receiving quotes in the next day or two for a new fuel pump system.
